Time to Rethink Our Zero Injury Goals as a Measure Of Safety

I'm probably going to go to "Safety Guy Inferno" for this, but I'm going to say it anyway. You see, I've come to realize that having ZERO injuries is not the best definition of safety. In fact, setting Zero as the ultimate safety goal actually demoralizes the very people we need to motivate to make our places of work safe. Oh, I can already hear the email programs opening to send me a flood of nasty emails about my not believing "all injuries can be prevented". Let me make myself perfectly clear: "I believe that all injuries can be prevented" so stop typing that email and please read the rest of the article.

Some Fundamentals

Here are some of my fundamental beliefs and some of the logic that tell me that Zero injuries isn't a definition of "safety" and that we need to re-examine what we talk about and what we recognize as success. I believe with great certainty that injuries are a result of energy hitting us with a force greater than our bodies can withstand or that our bodies don't get the energy we need (food, water, oxygen). If that's the case, then a state of "safe" will be achieved when we can reasonably expect that uncontrolled energy can't hit us and that the energy we need is there for us. It's very much about the act of not taking risks we don't have to when we are trying to produce a good or service.

So, if we set the goal of Zero injuries and we don't have any injuries then we must have reached our goal. Wait, I understand being happy about the result but I know that this is simply not logical nor is it even wise to say that we have been "safe" because we've had no injuries. Since we all know by now that not being injured while we do risky work happens a great deal of the time. This is akin to giving someone an annual safety award for being a "good ducker" and not getting hurt when all the time they have been taking terrible risks.

A definition of "safe" is not the absence of injury. So how can Zero be our definition of safe?

Now if a group of humans doing work for a period of time without any injuries is a result that we want then one could argue that it was "safe". However, we have tons of examples where people have worked long periods of time without incident then a catastrophic event happens. Often, through investigation, we find out that there were terrible risks being taken for some time before the incident occurred.

Now What?

So, continue to strive for ZERO, but motivate through measuring and rewarding the activities we do to create safety. If you get to a period of time when injuries are not happening, ask yourself if you know (with confidence) WHY you got that result. Is it because you've actually managed the work so any risks you are taking have been controlled to the point where no unnecessary exposure to energy is happening? Then I believe you can say with some confidence "We're SAFE!"

Feel free to debate among yourselves. I know that Zero injuries for a period of time doesn't necessarily mean your company is a safe place to work. Now if you can tell me with some certainty how you got there...I'll believe you!

Here's a very simple example of the comparison when using outcome injury measures:

Company A	Company B
Construction Site	Construction Site
2-storey building	2-storey building
Worker falls on concrete	Worker falls on fresh snowfall
Fatal injuries	No injuries
WCB Premiums - Up	WCB Premiums - No change
Bad press	No press
OH&S conviction	No OH&S conviction

Which company is safer?

Motivate Safety Activity – The Results Will Come

So let's re-examine what we are motivating people to do because what gets measured gets done. Let's measure our "creating safety" and not just our success in "avoiding injuries". If rewards and bonuses for your staff are based on Zero injuries, we'll motivate people to hide injuries or we could be rewarding luck. Even worse we could have a large group of people working very hard on making their place of work "safe" and because of a somewhat minor situation lose their celebration of all their accomplishments. If we're doing the right things and rewarding the act of producing safety...not many of us, if any of us, will get hurt!

Good luck and remember "Be kind to each other, we're all in this together!"

Alan D. Quilley (1954-2021), my late husband, was a proud CRSP and published author of 8 books solely dedicated to OHS. He spent over 4 decades working as a safety professional, and since 2003, was a highly successful and sought after OH&S consultant and trainer/mentor. In determining the direction of our newsletter, I've decided to reprint some of Alan's past articles as they are virtually timeless.

OHS Challenge: "Let's Discuss The Urgent Issues"

In a previous issue, Alan had asked readers to submit what they felt were their #1 urgent issues with respect to OH&S. Are these still your issues? Has anything changed? These are a few of the submissions we received...more next issue.

1. No budget for safety.

Companies are scrambling to stay alive. For example: I had a client call me in to prepare for an OH&S inspection. Once the inspection was done, everything we had prepared to do was shelved.

2. Addressing Occupational Health.

There is always pressure to keep people working in unhealthy environments. This is an ongoing issue but the pressure will be even greater this year. Companies focus on Safety because it has the most immediate consequence. This was evident with every organization I have worked with and was evident with every external audit I have done.

3. Keeping policy simple.

This is also ongoing. 5 page policies get read, 35 page policies gather dust.

1. Lack of Funds:

With the economic downturn, I see safety as being one area that might get cut back by accountants. As people are slated for lay-off, safety personnel might be placed into that category as they have no immediate effect on the bottom line.

2. Safety Courses at Colleges and Universities:

I see more and more OH&S courses coming on line without any sort of accreditation of the syllabus. A lot of students are going into this field never having worked at all at a full-time job. They look forward to simply getting 3 years of safety related work so they write for their CRSP. We need to assure that these courses are being properly taught. Then we need to have some sort of apprenticeship or mentoring system for these new safety people to assure they get proper training after they graduate.
